

Terms & Conditions

RENTAL FEES: Rental Fees are correct at time of printing and are subject to change without previous notice.

A minimum rental fee payment of 50% for any of the rooms is due and payable upon contract signature, balance due sixty (60) days prior to scheduled function. A damage deposit of \$ 350.00 is due and payable upon the contract signature. Any applicable deposit will be refunded by mail within 30 working days after the scheduled function, should no damage occur or should total damages not exceed the damage deposit .

Musical concerts or similar activities must provide a damage deposit of \$1,000.00 plus proof of liability insurance.

The Brownsville Events Center does not provide security for events. Renter will make arrangements to provide security from the Brownsville Police Dept. The requirement of security service does not in any way waive the responsibility for damages.

The Brownsville Events Center reserves the right to cancel any scheduled functions at any time, due to any critical situation or emergency.

Weddings, Quinceañeras, meeting groups, charitable organizations, schools and private functions may furnish food and other items to guests. No sale of these or similar items is permitted by persons other than the concessionaire or by the approval of the Brownsville Events Center.

BOOKINGS: Contact the Brownsville Events Center. All bookings should be made as early as possible to insure dates availability.

CANCELLATION: 6 months or less 50% non-refundable.

ROOM USE INTERRUPTION: No refunds will be given for unused services during the day of rental, unless arrangements are made prior to event.

RESPONSIBILITY: The responsibility of The Brownsville Events Center is limited. We are not responsible to any person for expense, loss of time or money or other circumstances resulting from a change of schedules, delayed or cancelled of other services related to the event, strikes, and other conditions beyond our control such as weather, any act as a result of Government Action, or an act of God. We act only in the capacity of arranging the availability of gathering space . We retain the right to make any changes to the service we provide and substitute the best alternative feature service.

ADDITIONAL HOURS: Additional hours exceeding the 8 hour leasing period will be charged at a rate of \$150.00 per hour (if ballroom is available). Additional hours between 12:00 a.m. and 1:00 a.m. will be charged at a rate of \$250.00 (Fridays and Saturdays only and customer must notify and pay the Events Center representative at least two weeks prior to event).
