**FY 2012/2013 One Year Action Plan Substantial Amendment**

Notice is hereby given that the City of Brownsville is proposing to do a Substantial Amendment to its Fiscal Year 2012/2013 One-Year Action Plan (October 1, 2012 through September 30, 2013). The purpose of the Substantial Amendment is (1) to comply with the Citizen Participation Plan and 24 CFR Part 91, as amended by the Interim Rule; and (2) to Reprogram CDBG funds.

Moreover, the purpose of this notice is to solicit input from interested parties on the Substantial Amendment that includes FY 2012/2013 CDBG grant funds. The Substantial Amendment includes reprogramming \$1,178,871.00 in CDBG funds previously allocated to (2) two FEMA Emergency Safe Rooms. Funding will be reprogrammed to increase the budgets of other HUD approved projects currently listed in the Fiscal Year 2012/2013 One-Year Action Plan.
