“STANDARD OPERATING PROCEDURES”

- 1. FIRE EXPLORER WILL BE IN FULL UNIFORM AT ALL TIMES DURING MEETINGS AND ALL FIRE EXPLRER FUNCTIONS. UNLESS TOLD OTHERWISEBY THERE ADVISOR.**
- 2. FIRE EXPLORER WILL BE ON TIME AT ALL FIRE DEPT. FUNCTIONS AND MEETINGS. IF THE EXPLORER CAN NOT MAKE THE TIME HE OR SHE NEEDS TO LET THE ADVISOR OR THERE CAPT. OR LT. KNOW AS SOON AS POSSIBLE.**
- 3. FIRE EXPLORER WILL NOT HAVE THERE CELL PHONE, OR ANYTHING ELSE THAT WILL DISTRACT THE EXPLORER FROM PAYING ATTENTION DURING TRAININGS, MEETINGS, AND FIRE DEPT. FUNCTIONS.**
- 4. FIRE EXPLORER WILL NOT SLEEP DURING TRAINING CLASS AND WILL BE ALERT AND READY TO PERFORM AT ANY MOMENT.**
- 5. FIRE EXPLORER WILL BE CURTIOUS AND POLITE TO THE ADVISORS, FIREFIGHTERS, AND TO THERE FELLOW FIRE EXPLORERS AT ALL TIMES!!**
